PURPOSE: An Ordinance to repeal the Millington Township Medical Marijuana Ordinance Number 11-1 for the health, safety and welfare of Township residents.

THE TOWNSHIP OF MILLINGTON ORDAINS:

**SECTION 1. REPEAL ORDINANCE NUMBER 11-1.**

The Township hereby repeals the Millington Township Medical Marijuana Ordinance, Ordinance Number 11-1, in its entirety.

**SECTION 2. VALIDITY AND SEVERABILITY.**

Any section or subsection not expressly amended by this Ordinance shall remain in full force and effect. Should any portion of this Ordinance be found invalid for any reason, such holding shall not be construed as affecting the validity of the remaining portions of this Ordinance.

**SECTION 3. REPEALER.**


Any ordinances or parts of ordinances in conflict herewith are hereby repealed only to the extent necessary to give this Ordinance full force and effect.

**SECTION 4. EFFECTIVE DATE.**

This Ordinance shall take effect seven (7) days after publication as provided by law.
