Abstained: Jaruzel. Motion denied. Cost of parts with the County were more expensive than McDonalds Chevrolet. On March 16th 2020 the board made a decision to use McDonalds Chevrolet for all repairs/maintenance.

Motion by Loomis, support by Jaruzel to all fire board to purchase furnishing for Fire Hall up to \$11,600. Ayes: Keinath, Loomis, Green, Sabgash and Jaruzel. Nays: none. Motion carried.
