It was agreed upon by the Township Board to have 1 pass of a 12ft spray be done as there would be added cost for an additional pass. Brush is encroaching onto Willard Rd causing a safety issue. Loomis will reach out to Lee Crosby about this issue. Township will start road side mowing in June which might help keep the brush back.

Township resident made a formal complaint against the Sheriff's Department in regards to an incident that took place 10 months ago. Resident did file complaint with Sheriff's Department at the time of the incident. The complaint was investigated by the Sheriff's Department and upon reviewing the body cam footage it was determined the Deputy did not violate protocol. The Township Board determined the resident needs to file current complaint with the Sheriff's Department.
