Sherry Morris: Loves being able to share the beauty of Murphy Lake with people and this ongoing dispute over STR's on the Lake is tearing apart friendships and the neighborhood.

Cody Clark: Clearing the air that they have not rented out their home on the Lake but it may be something they consider doing in the future. Explained his support for STR's. Tom Keinath: Shared his appreciation for the Millington Township Board.

Steve Ley: The evidence he turned in last month was not fabricated but facts from the Planning Commission meeting minutes.

Emry Close: It's not to late to enforce our Ordinances.

John Booko: STR's could impact the property tax, stated his property tax has went up a total of 56% in the past 3 years.

Mark Morris: The dispute on STR's is tearing the community apart and he would like to see the new ordinance amendments lower the percent of STR's in the Lake Residential district. He submitted a letter from the Tuscola County Planning Commission on the new STR ordinance amendments.

ZBOA Meeting: New Zoning Administrator T. Daenzer reported her findings on how the process of the SLUP application for the campground/mud bog was not in compliance with the Millington Township Ordinance. No action by the Township Board needs to be taken as she has been in contact with the Township Attorney and will have more information regarding next steps prior to the date of the adjourned ZBOA meeting scheduled for January 3, 2024
