Public Comment: Resident asked about ZBOA meeting date for the appeal on the campground/mud bog. ZBOA meeting date is Wednesday December 13, 2023 at 6pm Resident asked the Board to up hold the zoning ordinance and if we can't then to resign. Another Resident asked the Board to up hold the zoning ordinance. The board read letters from the residents opposing the campground/mud bog on Irish Rd along with a petition with 40 signatures opposing campground/mud bog. Letters will be given the ZBOA.

## A. Green entered meeting at 6:10pm

Bob Worth – voiced some concerns that the Township Board, Planning Commission and Zoning Administrator are not up holding the ordinances. Specific areas of concern were the Planning Commission By-Laws, Site Plan Review Requirements, Zoning Administrator & Ordinance Enforcement Officer Duties and Procedures for Special Land Use Approval by the Planning Commission. He addressed the board about an action taken during the August 21, 2023 meeting, and stated the extra duties needed to be voted on and approved before voting to pay said board member. He shared concerns about only allowing the residents to speak during public comment.

Steve Ley – submitted written charges for a conflict of interest with Planning Commission member Ed Maschke and his role in property setback changes and the STR's in the LR District and requests a public hearing be held to remove E. Maschke from Planning Commission. A petition with 100 signatures of those who oppose STR's in the LR District was submitted. He shared the by-laws of the Murphy Lake Association and pointed out the purpose of the Association and stated that Ed Maschke is the President of the Murphy Lake Association.

Motion by Keinath, support by Jaruzel to have the board investigate other attorney options that are working with other Townships and bring information back to the December 20, 2023 meeting.
