Ed Maschey stated that training is important. He will be retiring in 6 months and that will give him more time to devote to the PC. (Steve Ley interrupted several times)

Mark Morris STR owner and he thinks that Ed and Alvin's experience is valuable and needed on the PC. Said the board needs to work together and stop picking on Robert.

Jaruzel asked for a 5-minute break Took a 5-minute break.

Public comment started again.

Dan Davenport suggested that someone take a survey of Murphy Lake residents to see if the residents want str's or not. Threatened a lawsuit over sign violation letters.

Public comment closed

Keinath asked if we were going to give directions to the Zoning Admin as how we would like her to proceed with the ordinance violations. Loomis suggested she contact the attorney. The ZA asked how she should proceed with the fence violation and the shed violation. It was decided that the ZA will inquire about the fence and the shed violations with the Twp Attorney.

The ZA asked us about amending our Zoning Ordinance about storing a boat on property for only 90 days. Loomis asked if we could ask the PC to amend our 90 day limit of storing a boat on the property.
