- Jaruzel brought a draft of a Resolution to Reserve Final Approval for Mast Plan Adoption. (See attached)
- Jaruzel spoke about meeting minutes that the PC wanted her to change (referenced notes were about TCA and Midwest Motors) and what MTA and directed her to do. They also said that the minutes of a meeting can only be changed or corrected at a public meeting. And only at the next meeting following the meeting that the minutes are about. They also suggested that we reach out to our attorney about what happened and ask them to attend the next PC meeting. Loomis suggested that our attorney virtually attend the next PC meeting to save money.
- Mr. Maschke Clarified the latest requirements for PC to address concerns with the SLUP permit wording. He also asked if the PC is going to be on the Board agenda that we let them know so that we can get their viewpoint.
- Cameron brought two bids for the tree work that needs to be completed at the cemetery. She reached out to 3 different companies, 1 didn't respond. The bids were from Above All Tree Service for \$5,500 and One Call Tree Service for \$3,600.
- Keinath brought a draft of a policy for our digital sign.
- Cameron asked for compensation for the sextons, over and above their weekly pay, because of the storm damage they had to clean up. She requested 21²⁴ hours for each of them.
- Mr. Worth spoke.
