2 people spoke. One letter was read (see attached) Closed at 6:13.

New Business:

- Loomis shared about roadside brush spraying. He said that people can opt out if they do not want their yard sprayed and the township will only be charged for 1. the gallons used. The cost would be roughly \$15,000.
- Loomis talked about edge/fog lines need to get painted on Barnes Rd between Sheridan and Lane Rd. It will cost \$585. 2
- Loomis said that work needs to be done on gravel roads. He suggests that we work on Milliman between Willard and Arbela cost: \$33,300. Lane Rd north and 3. south of Barnes. Cost: \$24,850. Willard Rd between Sheridan and Washburn. Cost: \$15,950. Arbela Rd between Milliman Rd to Irish. Cost: \$16,050. Various other spots twp. wide. Sharon brought to Roberts attention that ditching needs to done on Arbela Rd between Fulmer and M-15.
- 4 Director Jon Ramirez - explained the new Public Alert Software. Stated that he is willing to set up accounts for those unable to do it for themselves. Also, mentioned that it would be helpful for us to send a letter voicing our support to the Commissioners.
- 5. Robert Benard - presented the ZBA updated bylaws, appeal applications, and compensation strategy, ZBA communications with property owners and Twp attorney at the next ZBA meeting.
- 6 Cameron asked for permission to use Bauckham, Thall as our FOIA attorney.
- Loomis expressed his dissatisfaction with our current lawyers and is interested in switching lawyer firms. 7.
- 8. Cameron wanted to make it clear that if we are going to vote to dismiss a blight violation that the violator needs to no longer be in violation of the ordinance. And that we may want to consider getting rid of some ordinances. The ZA included some suggestions for the Board to look over, so that the Board may give direction to the PC on how to bring some ordinances up to date. Keinath and Jaruzel voiced concern that the PC isn't listening to the ZA and they asked for support from Loomis. Cook suggested that Jaruzel take our approved minutes to the next PC meeting and then if the PC doesn't follow our directives then we have a leg to stand on and we can go from there.
- 9 Jaruzel discussed the moratorium of campers on lake properties. PC ask her to address the Twp Board about lifting the moratorium so that violations could be issued and also to get feedback from Twp residents about their preferences.

Zoning Administrator's Report

- The ZA talked about modifying 3 ordinances (see attached). The build code and blight ordinance would need to be updated by the PC. The updates to the 1. Municipal Civil Infraction Policy and Procedure would be updated by the Twp Board.
- The ZA drafted a Procedure for issuing Zoning Permits. She asked that we vote on this tonight, Loomis voiced that he'd like more time to look it over. 2.
- 3 The ZA asked about the sign ordinance violation 2025-005. The
