

## 2024 Millington Township Fee Schedule

The amount of any fees charged for zoning permits, applications, or inspections shall be established by the Township Board. [Section 3.02.F]

Any building or structure which is used, erected, altered, raised, or converted or any use of any premises which is begun or changed without a permit is subject to the Millington Township Civil Infraction Policy and Procedure.

Zoning Board of Appeals (regular meeting) ..... No Fee, actual costs assessed as outlined in Article 19.02.  
Zoning Board of Appeals (special meeting) .....\$250.00 and any additional costs when incurred.

Land Division (first division) ..... No Fee  
Land Division (each additional division) ..... No Fee

Lot Line Adjustment ..... No Fee

The fee shall also be limited to actual mailing costs and actual incremental costs of duplication.”

Notary Fees (per signature) ..... \$5.00

Schedule of Civil Fines/Costs:

Civil fines payable to the Bureau upon admissions of responsibility by a person served with a municipal ordinance violation notice shall be pursuant to the following schedule:

1<sup>st</sup> violation within a 2-year period\* ..... \$250.00\*\*

2<sup>nd</sup> violation within a 2-year period\* ..... \$500.00\*\*

3<sup>rd</sup> or subsequent violation within a 2-year period\* .....\$1500.00\*\*

\*As determined based on the date of violation

\*\* Additional costs may be assessed to include all direct or indirect expenses to which the Township has been put in connection with the violation. A violator of this Ordinance shall also be subject to such additional sanctions, remedies, and judicial orders as are authorized under Michigan law.
